



## **BARRICADE® UDL WARRANTY**

### **BARRICADE® UDL 20-Year Limited Warranty\***

Use of the Barricade® family of UDL synthetic roof underlayment products installed per the installation instructions; entitles you to certain quality assurance standards as provided in this Barricade® UDL 20-Year Limited Warranty (“Warranty”).

### **What Is Covered**

Barricade Building Products (“BBP”) warrants that Barricade® UDL products (UDL Pro, UDL Standard, UDL One, UDL Plus [25 year], UDL Select [30 year]), originally installed after January 1, 2014 will have the ability to shed water and maintain structural integrity, for a period of twenty (20) years after the date of purchase of the Barricade® UDL product, except as noted below.

### **This Warranty Does Not Cover Any Damages Arising From**

(a) The negligence, gross negligence or willful misconduct of any third party; (b) Acts of God, including but not limited to, fire and lightning, hurricane, high winds; (c) Vandalism by any party; (d) Defects in the structure or a component of the structure (e.g., shingles, skylights or flashing materials) or selection of any components of the structure, or premature deterioration of the building materials, or nonstandard use of application of the Barricade® UDL; (e) Foreign objects or agents, including incompatibility of materials; (f) UV exposure of the Barricade® UDL in excess of that set forth in the Physical Properties Data Sheet; or (g) Improper installation of the Barricade® UDL, improper building practices or design not in accordance with the applicable building code or industry standards, or any deviation from approved construction plans or project specifications. The Barricade® UDL must be installed in accordance with the Barricade® Building Products Installation Guide that is in effect at the time of the installation of the Barricade® UDL. ### **How Long Coverage Lasts**

This Warranty runs for twenty (20) years from the date on which the Barricade® UDL was originally installed as a standard part of the roof system. If the Barricade® UDL is repaired or replaced, the Warranty will continue from the original date of installation and not from the date of repair or replacement.

**Who Can Enforce This Warranty**

Any owner who can provide proof of installation of the Barricade® UDL after January 1, 2014 on a construction covered by and meeting the terms of this Warranty can enforce this Warranty. This Warranty is transferable to subsequent owners within the Warranty's 20-year coverage period. Notwithstanding the foregoing language, BBP shall have no obligation under this Warranty unless and until BBP, the authorized applicator, and the material suppliers have all been paid in full for all materials, supplies, services, and other costs which are included in, or incidental to, the Barricade® UDL.

**What BBP Will Do and What You Must Do**

BBP will repair or replace the product or refund the purchase price for that portion of the product that has been proven to be defective. You will be responsible for any other costs associated with or arising out of the repair or replacement or any other correction. You must reasonably cooperate with BBP or its representatives in their efforts to perform their obligations under this Warranty.

**How You Can Get Warranty Service**

To obtain service under this Warranty, you must promptly contact BBP at [www.barricadebp.com](http://www.barricadebp.com) or call 1-877-832-0333 regarding any potential claim, but no later than sixty (60) days after you discover any potential claim and provide BBP with proof of purchase and installation of the Barricade® UDL. You must provide BBP with a reasonable opportunity to inspect your home within sixty (60) days after BBP receives notice of your potential claim.

**Exclusion of Damages**

BBP'S LIABILITY UNDER THIS WARRANTY IS LIMITED TO THE COST OF THE MATERIALS PROVEN TO BE DEFECTIVE. BBP SHALL NOT BE LIABLE EITHER IN TORT OR IN CONTRACT FOR ANY DIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, OR LOST PROFITS, LOST REVENUE, OR LOSS OF USE, OR ANY BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.

**Limitation of Implied Warranties**

ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS LIMITED IN DURATION TO THE LENGTH OF THIS WARRANTY.

The foregoing is the only Warranty made by BBP for the Barricade® UDL. No representative, dealer or any other person is authorized to make or makes any warranty, representation or promise on behalf of BBP with respect to the Barricade® UDL. No terms or conditions other than those stated herein or provided by law, and no agreement or understanding, oral or written, in any way purporting to modify this warranty shall be binding upon BBP unless made in writing and signed by an authorized employee of BBP. This Warranty gives you specific legal rights; other rights may also be available which may vary from state to state or, in Canada, from province to province. This 20-Year Limited Warranty coverage for the Barricade® UDL is your ultimate assurance of lasting quality.
